Sealed tenders (to be addressed by name of S Jones Justin, I.F.S and not by official designation only) are invited from the *bonafide* Boats/Launches owners by the undersigned for engaging of Boats/Launches (6 Cylinder, 4 Cylinder, 2 Cylinder & 1 Cylinder) for patrolling purpose in Sundarban Tiger Reserve on daily haring basis excluding P.O.L. Technical and Financial bids shall be submitted separately.

- 2. Financial Bid is also to be submitted in the prescribed proforma as available with the Tender Paper in a sealed cover super scribed as "Financial bid for hiring of patrolling boat for deployment in the jurisdiction of Sundarban Tiger Reserve against Schedule.......... & Sl. No........." and should be addressed by name to "S Jones Justin, IFS, Deputy Field Director, Sundarban Tiger Reserve, PO. Canning Town, Dist. South 24-Parganas, Pin. 743329" and not by designation.
- 3. The Tender Committee shall first open the Technical Bid and place it before the Technical Committee for evaluation and consequent reporting to the Tender Committee after proper physical verification. The Financial Bid will be opened in respect of those qualified tenderer as per recommendation of the Technical Committee.

4. The Tender paper along with requisite proforma shall be obtained from all the Range Office. i.e. The Head Quarter Range, Canning, The Sajnekhali Wildlife Sanctury Range, Pakhirala, The Bashirhat Range, Jhila, The National Park East Range –Gosaba, The National Park West Range, Vidya after depositing Tender Fee of Rs. 750/- (Rupees seven hundred only) under H/S. 0406-01-800-021-27 through GRIPS Portal. Tender shall be deposited at the same place from where tender paper is obtained.

#### The following Terms and Conditions shall be applicable

- 1 The rate to be offered on daily basis except charges of fuel.
- 2. The reserve rate of hiring charge on daily basis will be

- 3. A Tenderer is required to quote rates, in figures as well as in words. If the Tenderer quote rate 15% above or below of the Reserve Rate, Rate analysis may be enclosed along with the quoted rate. In case same rate quoted by more than one Tenderer, the authority shall have the liberty and discretionary power to take final decision which shall be final and binding.
- 4. The Range Officer, should check the boat before issuing tender documents and give a Clearance Certificates stating that the boat is as per conditions prescribed in the tender norms.

- 4. The bill should be submitted by the approved Boat owner after necessary checking from the concerned Range Officers. The logbook of the Boat should be maintained on day to day basis by the boat owner and countersigned by the officer using boat.
- 5. The Boat will be engaged for a period of 1 (one) year against the approved rate. The engagement will be terminated after one year of issuance of work order or otherwise if required.
- 6. If performance is not satisfactory or if boat owner/Serang/Crew member is involved in any malpractice or violation any forest law his contract will be terminated and action as per law will be initiated. The termination will be effected due to unsatisfactory performance with prior notice of 1 (one) month.
- 7. The Boat can be allotted to any Camp/Beat in the operative jurisdiction as per the details given in Tender.
- 8. The Boat will be working under the supervision of Camp/Beat in charge of respective Camp/Beat. Any violation for the duty allotted by the Camp-in-charge /Beat Officer or any other Superior Officer (in which Camp/Beat the Boat will be deployed) or any type of disobedience for Government duty will be taken seriously and liable for to cancellation of the work order.
- 9. The Boat owner does not employ any labour below the age of 14 years as per strict order by Labour Department.
- 10. The Boat owner shall engage minimum 4 person for 6Cylinder Launch, 3 persons for 4 Cylinder/6 Cylinder Boat, 2 persons for 2 Cylinder Boat.
- 11. Payment will be made to the proper owner of the boat (subject to authentication) through epayment on monthly basis after receipt of bills forwarded by the respective Range Officer.
- 12. Necessary Taxes will be deducted as applicable.
- 13. The payment of the bill will be made as per fund availability.
- 14. The engaged Boat/Launch must have 1(one) number of cabin for accommodation along with two toilets and dinning space except for 1 Cylinder Boat.
- 15. It must be manned with sufficient crew members with sufficient insurance coverage for life and injury.
- 16. The Boat/Launch must possess safety certificate from competent authority.
- 17. It must have a minimum experience of 5 (five) years in performing duties in similar areas.
- 18. The participant Tenderers will have to deposit EMD (Earnest Money Deposit) in Bank Draft in favour of Deputy Field Director, Sundarban Tiger Reserve.
- 19. The Tenderer should have proper Trade License, IT clearance, Bank Account along with other necessary formal documents (PAN, GST etc.). A copy of which shall be attached with Tender paper.

- 20. Tender will be executed on 2<sup>nd</sup> Bid system, Technical Bid followed by Financial Bid. Financial Bids will be opened only in respect of tenderers have qualified in Technical Bid.
- 21. The decision of the Deputy Field Director, Sundarban Tiger Reserve, shall be final and binding incase of any dispute regarding the matter.
- 22. The Chief Conservator of Forests & Field Director, Sundarban Tiger Reserve, shall be the appellate authority in case of any grievance against the order of the Deputy Field Director, Sundarban Tiger Reserve.
- 23. The tenderers are required to go through the terms and conditions carefully and inspect the sites, before submission of the tender and in future, ignorance about any matter shall not be considered as any valid ground under any circumstances.
- 24. The Boat/Launch will be the disposal of Sundarban Tiger Reserve on 24 hours basis. The boat should not move out of station without prior written permission of the camp in charge.
- 25. The undersigned reserves the right to cancel the agreement at any point of time of execution.
- 26. The successful tenderer will not assign any or part of the work to any other contractor.
- 27. The tender notice along with all terms and conditions mentioned above will form the part of the agreement to be executed by the tenderer.
- 28. The undersigned has the authority to reject any or all Tenders received without assigning any reason thereof.
- 29. The undersigned has the full authority to change the camp location at any time as when necessary
